# REGULAR MEETING MINUTES OCTOBER 5, 2023 7:00 P.M.

The Regular Meeting of the Township Committee of the Township of Montgomery was called to order by Mayor Keenan at 7:00 p.m.

**MEETING NOTICE**: Mayor Keenan noted that adequate notice of the meeting was provided to the Courier News and Start Ledger, posted on the municipal bulletin board and filed with the Township Clerk as required by law on January 5, 2023.

**SALUTE TO THE FLAG:** Mayor Keenan led the Pledge of Allegiance.

#### PROCLAMATION - RECOGNIZING OCTOBER AS BREAST CANCER AWARENESS MONTH

WHEREAS, October is National Breast Cancer Awareness Month, an annual campaign dedicated to raising awareness about breast cancer; and

WHEREAS, National Breast Cancer Awareness Month aims to enhance public understanding of the significance of early detection and treatment; and

WHEREAS, despite research highlighting mammography as the most effective means of detection to reduce mortality rates, many women do not undergo regular screenings; and

WHEREAS, a pivotal message in the awareness campaign is the American Cancer Society's recommendation for women to receive annual mammogram screenings starting at age 40; and

WHEREAS, the National Cancer Institute estimates that in the United States, over 297,790 women and 2,800 men will receive a breast cancer diagnosis this year, with over 43,700 women succumbing to the disease; and

WHEREAS, breast cancer affects not only 1 in 8 women but also approximately 1 in 1,000 men during their lifetimes; and

**WHEREAS**, early detection methods like mammography and clinical breast exams have the potential to reduce the breast cancer mortality rate by approximately thirty percent.

**NOW, THEREFORE, BE IT PROCLAIMED** that the Township Committee of the Township of Montgomery, County of Somerset, New Jersey hereby recognizes October 2023 as Breast Cancer Awareness Month and encourages all citizens to increase their knowledge and understanding of the importance of early detection and treatment of breast cancer and demonstrates continued support by displaying pink ribbons throughout the Municipal Complex and Otto Kaufman Community Center during the month.

At this time, Montgomery Township Police Director/Captain, Silvio Bet, spoke of Police Department initiatives in support of Breast Cancer Awareness Month advising that the Department outfitted one of the patrol cars with pink lettering which was displayed at Somerset County's Pink Car Ceremony, Tuesday, October 3 and at the "Coffee with a Cop" event, Wednesday, October 4. Captain Bet explained that the car will be displayed during the month of October on patrol, and at road jobs and other Township events such as Trunk or Treat.

#### TOWNSHIP COMMITTEE REPORTS

Committee Member Ahn reported on the completion of replacement tree plantings on Dehart Drive and advised on funding on behalf of the Shade Tree Committee. Committee Member Ahn announced that the Economic Development Commission is sponsoring a "Hops and Shops" event at Iron Peak in Hillsborough, Saturday, November 4. Committee Member Ahn explained that the event is being held in Hillsborough, as there is no indoor venue in Montgomery that can accommodate this size event.

Committee Member Taylor Todd reported on July, August and September meetings of the Landmarks Preservation Commission advising that a speaker from the NJDEP Office of Climate Resilience provided an overview on the impact of recent severe storms and flooding on the Central New Jersey Historic District; and that discussions were held regarding the 2024 publicity brochure and historical marker signage for the "W3R" revolutionary trail located at the Southern edge of the Township. Committee Member Taylor Todd also advised that Commission members are looking to hold a small reopening ceremony for the Rock Brook Bridge. Committee Member Taylor Todd also advised of the Township's participation in Somerset County's "Journey Through the Past" Event, October 7-8.

Deputy Mayor Singh reported that the Township's pedestrian safety public outreach for raising awareness of the dangers of crossing Route 206 has been successful and highlighted some of the initiatives. Deputy Mayor Singh advised that an additional town meeting is being planned and that homeowners' associations are assisting with outreach as well. On behalf of the Board of Health, Deputy Mayor Singh provided information regarding Covid-19 vaccines and advised of an upcoming presentation, Tuesday, October 10, recognizing and dealing with anxiety in children by a local psychologist.

Mayor Keenan reported that the Environmental Commission met at the Watershed Institute in Hopewell where members were given a tour of the facility. Mayor Keenan advised that the meeting included a presentation on municipal stormwater rules and regulations. Mayor Keenan commented that the schools are now "River-Friendly" and announced the following upcoming events: October 22, Build Your Own Scarecrow at Veterans Park; October 27-29, Return to Art; October 28, Howloween at the Farmers Market; and October 28, Trunk or Treat at Montgomery High School with new hours from 4:00 p.m. to 6:00 p.m.

Mayor Keenan also reported on a meeting of the Master Plan Committee advising that discussion was held regarding patios and decks; the municipal stormwater plan; and the Township's wind, solar and photovoltaic ordinance.

Mayor Keenan referred to Somerset County's recent newsletter advising that approximately \$7.6 million of the County's \$22 million in state aid is going towards projects in Montgomery.

During Township Committee reports, Committee Member Ahn commented on the importance of considering noise levels and RPMs for windmills. Mayor Keenan added that Narcan training is available virtually and anyone interested can visit the Township website for details.
