# MINUTES FOR MONTGOMERY TOWNSHIP COMMITTEE February 16, 2023 7:00 p.m.

1. Montgomery Township Committee met at 7:00 pm on the above date at the Municipal Complex, 100 Community Drive, Skillman, NJ. Those present were:

- 2. Mayor Keenan stated the following: "Under the provisions of the Open Public Meetings Act, notice of the time and place of this meeting has been posted and sent to the officially designated newspapers."
- Mayor Keenan led the salute to the flag.

#### 4. FINANCIAL UPDATE SHARED SERVICES

Chief Financial Officer Michael Pitts gave a presentation on Shared Services. Items discussed were:

#### 5. Road Capital Program

Township Engineer Mark Herrmann gave a presentation on the Road Capital Program. Items discussed were:

- Maintenance of Roads
- Routine Measurements and Checks
- Upgrades of Curbs, Street Signs and Sidewalks
- Sewer Inspections
- 5-1. Mayor Keenan commented that as a Township Committee one of their priorities is getting sidewalks implemented and it seems like they are in alignment with the program.
- 5-2. Deputy Mayor Singh asked how often do they go back to check on the maintenance of the roads. Mr. Herrmann responded that they will go back out and check for cracks every two to three years. They will prioritize the newer roads first and share their data with Public Works.
- 5-3. Mayor Keenan asked if there is a public list of roads to be worked on. Mr. Herrmann responded that the public can give him a call to find out what roads are being worked on. When people call throughout the year, they take those into consideration priority wise to be worked on.
- 5-4. Deputy Mayor Singh asked for roads that need repair that go into County lines, what is the process for that. Mr. Herrmann answered there is an agreement that any roads that overlap either town can service them if needed.

Committeeperson Barragan gave praise to both the Township Administrator and Township Engineer for taking initiative and discussing these topics to give transparency to the public so they can understand what's happening as well as putting more maintenance in now in order to save the roads for the future.

# D. RESOLUTION #23-2-71 - AUTHORIZING RELEASE OF PERFORMANCE GUARANTEE FOR 71 COLFAX ROAD-BLOCK 31002, LOT 22

WHEREAS, Mark Herrmann, Township Engineer, has certified on February 9, 2023, that Alexander and Natasha Wolfson have completed the improvements for 71 Colfax Road. The improvements are acceptable and he recommends that the Township Committee consider the release of the Performance Guarantee. It is recommended that the release include the following conditions:

1. Alexander and Natasha Wolfson shall post a two-year maintenance guarantee in the amount of 15% of the original Performance Guarantee amount of \$30,985.00 which is:

15% Maintenance Guarantee = \$4,647.75

2. Alexander and Natasha shall post adequate escrow funds, as determined by the Township Engineer.

WHEREAS, upon satisfactory completion of these conditions, it is recommended that the Township  $\underline{accept}$  the following:

• Storm Sewers - including but not limited to a storm inlet installed in Colfax Road along Block 31003 Lot 22 and the conveyance piping to an existing storm inlet in Colfax Road along Block 31003 Lot 23, as shown on the attached sketch.

WHEREAS, the following improvements will not be accepted by the Township:

- Driveways all driveways, driveway aprons, driveway sidewalk, or associated depressed curbing associated with the driveway for Block 31003 Lot 22. This shall be maintained by the property owner(s) of Block 31003 Lot 22.
- Stormwater Management Facilities (e.g. drywell, vegetative swale, etc.) all Stormwater Management Facilities including but not limited to the drywell at Block 31003 Lot 22 and the overflow connection into the Colfax Road storm sewer shall be maintained by the owner(s) of Block 31003 Lot 22.
- Other Improvements any other improvements not specifically listed as being accepted by the Township.

# E. RESOLUTION 23-2-72 - AUTHORIZING RELEASE OF LANDSCAPING GUARANTEE FOR 71 COLFAX ROAD - BLOCK 31003, LOT 22

WHEREAS, Mark Herrmann, Township Engineer, has certified on February 9, 2023, that Alexander and Natasha Wolfson have completed the improvements for 71 Colfax Road. The improvements are acceptable and he recommends that the Township Committee consider the release of the Landscape Buffer Guarantee. It is recommended that the release include the following conditions:

- 1. Alexander and Natasha Wolfson shall post a two-year maintenance guarantee in the amount of 15% of the original Performance Guarantee amount of \$11,880.00 which is:
  - 15% Maintenance Guarantee = \$1,782.00
- Alexander and Natasha shall post adequate escrow funds, as determined by the Township Engineer.

The Township will not accept any improvements as part of this guarantee release.

#### F. RESOLUTION #23-2-73 - AUTHORIZING 2023 SUSTAINABLE JERSEY GRANT APPLICATION

WHEREAS, a sustainable community seeks to optimize quality of life for its residents by ensuring that its environmental, economic and social objectives are balanced and mutually supportive; and

WHEREAS, Montgomery Township strives to save tax dollars, assure clean land, air and water, improve working and living environments; and

WHEREAS, Montgomery Township is participating in the Sustainable Jersey Program and been continuously certified since 2009, with most recent re-certification at the silver level in 2021; and

WHEREAS, one of the purposes of the Sustainable Jersey Program is to provide resources to municipalities to make progress on sustainability issues, and they have created a grant program called the Sustainable Jersey Small Grants Program; and

WHEREAS, Montgomery Township desires to complete a fleet inventory to gather baseline documentation on all municipal vehicles, with an eye toward the long-term goal of converting the municipal fleet to alternative fuel source vehicles.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Montgomery, County of Somerset, State of New Jersey authorizes the submission of the aforementioned Sustainable Jersey Grant.

- 1. The Mayor and Clerk shall be and are hereby authorized to execute a Shared Services Agreement with Pennington Borough for animal control services for a three-month period, beginning January 1, 2023 and ending March 31, 2023.
- A copy of said agreement shall be kept on file with the Township Clerk and available for public inspection during normal business hours.
- 3. This agreement is contingent upon both parties executing a resolution authorizing the agreement.
- J. RESOLUTION #23-2-77- AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT PURSUANT TO N.J.S.A. 40A:65-1, et seq., WITH PENNINGTON BOROUGH FOR HEALTH SERVICES

WHEREAS, the governing bodies of the Township of Montgomery and Pennington Borough desire to execute a shared services agreement pursuant to N.J.S.A. 40A:65-1, et seq., for health services; and
