Chair Massand called the meeting to order at 6:01 p.m. and read the opening statement.

II. INFORMAL APPLICATION

Joseph Petrovics and Christopher Covault presented proposed improvements to the accessory structure at 439 Route 518 that is used as an art studio. Christopher Covault described the site using an aerial image. He showed photos that were taken by Chair Massand when some of the Commission members visited the site. Plans were shown including the first floor plan, second floor plan and elevations. Mr. Petrovics may put solar panels on the roof.

The Landmarks Commission had POSITIVE comments about the potential project to expand the workshop, following a March 20, 2024 site visit in Blawenburg by Chair Massand, Commission member Havens and Sonya Hunt with details presented at the Petrovics property.

The applicants were welcome at the time of their Informal application, and a consensus to present a Preservation Plan has been achieved (meaning Petrovics and Landmarks both agree for this being a next/future step.)

Case BA-04-23Applicant: Renard Management, Inc.Block 29002 Lots 49 & 50 – 1026 Route 518Construction of a self storage facility

4. Mayor's Wellness Campaign. Township Committee and interdepartmental collaborations.

a. Japanese Tea Ceremony by artist Simon Keller - Library program room. Sunday date?

The date and time for a Japanese Tea Ceremony event in the Library will be announced. Chair Massand explained the tea is served in pots made out of New Jersey clay.

b. "History Hike (or stroll)" at Montgomery Veterans Park. Historical signage on paved pathway Music + tables.

The Commission discussed the signage at Veterans Park and photos of the signs were displayed. The Girl Scouts installed the signage a long time ago. The signs can be utilized to help guide the Landmarks Commission on interpretive signage.

Committee Person Todd explained the Wellness Campaign is to encourage wellness through traditional events that have wellness components such as the Farmers Market.

Dawn Hammell, Runette Parker and Sonya Hunt were appointed to a Committee to work on wellness event suggestions.

A tour of historic sites was suggested as an event. Members of the Youth Leadership Council could give informational tours.
